Hey Folks,

It's that time of year. It's dark earlier and School is in session. Please slow down and give our children the safe space needed as they get on and off their school buses.



Winter is just weeks away. Things are brown, cold and breezy. Aren't you glad you are not a bee! I wonder how they feel flying out and not seeing any flowers left.

Well, this is the time they have been preparing for, and why you have been helping them with all that sugar water you gave them! If you are not sure now what to do over the next four cold months perhaps a few pointers will help. Here are some of my thoughts about December and Bee-yond. If you have done most everything right up until now, these three key points will help the girls and Queen Mother survive through the winter: Moisture control and ventilation, winter inspections, and feeding during the winter.

Inadequate ventilation can cause moisture to condense and freeze on the inner cover and drip down when it thaws. This water can be near 32 degrees and can chill and kill bees if it drips on them. The bees cannot move out of the way if they are stuck in their cluster. This moisture is partly the product of the bees' bodily activity just as you breathe out frost in cold air. The easiest way to tell if ventilation is adequate is to look at the underside of the top cover. Dry wood, probably ok/might be too much; damp wood, may need more ventilation, water condensation on wood, Houston we have a problem!

As you can see it is somewhat of a balancing act. I have learned through the years that a moisture box is about the best all-around tool to help control moisture in the colony. Simply, it is a box with the

same dimensions as a super only it is just four to five inches deep with a screened bottom using 8 mesh screen stapled to the bottom. I put burlap on the inside on top of the screen and then put two to three inches of wood shavings on top of the burlap. This box can go directly on the top of the inner cover or if you are feeding fondant or grease patties, you can leave off the inner cover and put the moisture box right on the top of the hive box. Just make sure you have top ventilation/ upper escape holes on your top hive box. Your mouse guards and entrance reducers should be in place. Don't worry too much about snow. If you pick up a big handful you can breathe through it (I had to try this before I stopped worrying). That said it is easy enough to clear off snow when you have hives at home if it is safe to walk to

them. But Winter yards are usually unsafe to get to in such conditions so it is best to just not worry about clearing off the snow during normal snowfalls. Heavy ice might need to be removed if it were to seal the entrance-just depends. Don't go out and take a fall and injure yourself for this. So basically-safety first on snow and ice. And besides, the upper ventilation/escape holes should be adequate for ventilation of the hive

Winter inspections: You can inspect a hive in winter if you do it under the right conditions and for the right reasons. In fact you *need* to inspect your hives. I am not talking about pulling everything apart. Nor am I talking about thinking you have to go in there every week. When you do inspect bee sure to bee *very very gentle*  Page 6

and do not slam the lids or pop off the inner cover with a fast motion. This would upset the bees and they might be inclined to investigate. Plus, if it is cold they are mostly idle and should stay so. I almost never remove boxes even when weather is warm as the propolis seal is broken and drafty air could then come in. I also normally don't pull frames. Do NOT spend much time with the hive open. One or two minutes is plenty to see what you need to see unless you are doing a post mortem. You will want to take the opportunity when it is presented to check for several things over the winter: •Are they alive?• Where is and how big is the cluster?

•Do they need food? •Are their numbers dwindling?

On to Feeding: Your feeders should be off now. In other words all you have up top there is the inner cover, moisture box and top telescoping-cover. By the way, do not underestimate the strength of winds in winter. I have had wind over 90mph at my house and numerous instances of wind in the 60s. I have cargo straps that go completely around my hives and stands and I secure the stand legs to t posts driven into the ground.


If you do have to feed at some point in the winter, determined by winter inspections, you must *not* use bucket or jar feeders now that there are cold nights. Those feeders can draw air in when it gets cold then pump deadly cold syrup onto the bees when air in them expands.



bars (of top box) with a shim as cake may be 1-2" thick or so. Since the bees are probably near the top they can get to this readily even if it's somewhat cool as their heat rises up to the candy. So much information to share, so little space in which to share it! As always, use the Internet as a resource for questions and information. Bee thinking about what you need to do for Spring and, if you are thinking of ordering packages, nucs, or queens, do this in early January.



How much food do the girls need to survive the winter? I weigh my hives after I have pulled off the honey supers. The hives should weigh at least 70 to 90 pounds! If any do not, mark light ones in your journal as light hives and keep an eye on them throughout the fall. Remember the mantra for fall: Feed Feed Feed!

If you do need to feed in December or in January you should make grease patties and/or fondant cakes. Grease patties or a cake of fondant candy is placed on the top

Kim Stafford is the founding director of the Northwest Writing Institute at Lewis & Clark College, where he has taught writing since 1979. He is the author of a dozen books of poetry and prose, including The Muses Among Us: Eloquent Listening and Other Pleasures of the Writer's Craft and A Thousand Friends of Rain: New & Selected Poems.

His most recent books are 100 Tricks Every Boy Can Do: How My Brother Disappeared, Wind on the Waves: Stories from the Oregon Coast, and Wild Honey, Tough Salt.

In 2016 the 30th anniversary edition of his collections of essays, Having Everything Right, came out from Pharos Editions. He has taught writing in dozens of schools and community centers, and in Scotland, Italy, and Bhutan. In 2018, Gov. Kate Brown named him Poet Laureate of Oregon for a two-year term.

#### PLAYA Awarded More than \$120,000 in Grants

PLAYA, an artists' and scientists' residency program, has received more than \$120,000 in grant awards in 2019 to support its mission, programs and projects. Grants were received from the Ford Family Foundation, Kinsman Foundation, James F. and Marion L. Miller Foundation, National Endowment for the Arts, Oregon Arts Commission, Oregon Community Foundation, Oregon Cultural Trust, Oregon Humanities, Reser Family Foundation, Ronald W. Naito MD Foundation and Travel Southern Oregon. The Oregon Community Foundation, Oregon Arts Commission, Oregon Cultural Trust and Ronald W. Naito MD Foundation Award Operating and Organizational Support PLAYA was pleased to receive three grant awards for general operating support and three for organizational advancement. The Winter Rim Fund of the Oregon Community Foundation awarded \$30,000, the Oregon Arts Commission granted \$6,499 and the Ronald W. Naito MD Foundation awarded \$10,000. These grants support the daily operation of the PLAYA artists' and scientists' residency program. In addition, the Oregon Community Foundation awarded a \$5,000 technical assistance grant for financial analysis. ## <u>Gluten Free 'Fallen' Chocolate Cake</u>

We made this dessert for our Valentine's Weekend Special at the Flyway restaurant on the advice of our Chef Jason, who said it was the most fabulous chocolate cake he had ever tasted! We agree with him

According to the internet blog.redvelvetnyc.com, this cake was created by an accident in someone's kitchen–(there are several stories) so it's often called "uno dei pasticci più fortunati della storia" or one of history's most fortunate mistakes.

For those of you on a gluten free diet, if you love chocolate, you will know rapture. You can substitute semi sweet for the bittersweet chocolate if necessary but it will not be as bold a flavor. Some renditions add some vanilla and/ or espresso powder. We chose to keep it purely, intensely chocolate.

Incredibly Simple Ingredients

11b of bittersweet chocolate <sup>3</sup>/<sub>4</sub> cup sugar 6 large eggs <sup>1</sup>/<sub>2</sub> cup real butter (1 cube)



•Set oven for 325° F

•Cut a circle of parchment or wax paper to fit in the bottom of an 8 or 9inch cake pan.( Just trace around bottom of pan for pattern.) Use a spring form pan if you have one but it's not necessary. Grease your pan and place parchment in bottom; then grease it too.

•Put about 1/2 inch of water in bottom of another oven-proof pan (such as a roasting pan) that is larger than cake pan for a water bath. This will prevent the top of

CHEESY BREAD PUDDING WITH MUSHROOMS AND LEEKS or MUSHROOM LEEK STRATA

This dish is incredible comfort food for these cold snowy days! Double the recipe and freeze half for later if you like. This serves 10 or 12 as a side dish but we use it as a main dish serving 5 or 6 by adding a cup or two of left over chicken or ham to the mix.

#### 2 1/2 Tbsp Butter

- 1/2 a 1 lb. loaf of Sourdough Bread, cubed
- 2 leeks, halved, cleaned and sliced thinly
- (we have used 1 lg yellow onion when leeks unavailable)
- 3 cloves Garlic, smashed & minced
- 6 oz or so wild or other fresh mushrooms, sliced ( we use dried
- wild porcini and meadow mushrooms from our lawn)
- 1/8 tsp sea salt
- 1/8 tsp fresh ground pepper
- A Slosh of (2 Tbsp) dry white wine( I had dry vermouth)
- $1\ 1/2\ C$  heavy cream
- 4 or 5 Jumbo eggs
- 1/2 C grated Parmesan Cheese
- $1/2\ \mathrm{C}$  shredded Gruyere Cheese ( Swiss works well too)
- 1 1/2 tsp snipped fresh thyme
- 1 1/2 tsp snipped fresh parsley
- Optional: 2 cups leftover shredded chicken or cubed ham

Butter a 2 quart baking dish with 1/2 Tbsp butter

If using dried mushrooms, reconstitute in cup or so of boiling water in microwave for 30 seconds.

•Mix eggs and sugar in a stand mixer until foamy. Just turn on and let mix on med or high for about 10 minutes.

•Melt chocolate and butter in double boiler (or microwave) stirring as it melts. •Wisk Chocolate mixture into the egg mixture till thoroughly combined and pour all into the parchment lined cake pan.

•Place pan in water bath making sure water is only about 1/2 way up side of cake pan.

Bake for 30 - 40 minutes or until cake is firm but still jiggles a bit. Or when table knife inserted in center comes out clean.

That's the basic cake. For an over the top version, make a *ganache* of 1 cup semi or bittersweet chocolate chips and ½ cup cream melted and whisked together. Pour this over cooled, unmolded cake drizzling down sides. Add raspberries or raspberry sauce to the plate for garnish if desired. Gotta go now. I need some chocolate!

Melt 2 Tbsp butter in large skillet over medium heat. Add leeks and garlic and cook stirring, until leeks begin to soften, about 10 min. Add Mushrooms and Salt and Pepper and cook stirring until mushrooms soften, another 10 minutes. Mix in the slosh of wine and cook 1 min more.

Add bread cubes to skillet and toss with mushroom mixture, then put into buttered baking dish. Add meat if desired.

Whisk together Cream, Eggs, 1/3 cup of each cheese and the herbs in a bowl. Pour over bread mixture. Chill, covered overnight.

Uncover pudding and sprinkle remaining cheeses over top. Bake in a 375° oven until table knife comes out clean from middle of pudding and top starts to brown, about 40 minutes. Let rest 10 minutes before serving with a crisp green salad. Salute'

The Prospector and his writing travel a path that has many curves and bends along the way, but in the end an interesting destination is reached. So spend a little time mulling over the journey and if you are curious like me, you may find yourself getting ready to do a little exploring.



When the Pilgrims were landing on Plymouth Rock the Shoshoni Warriors of the Ochocos were

laying siege to the town of Santa Fe to free their Brothers the Hopi, Zuni, and Pueblo Indians who were enslaved by the Spaniards. Riding six abreast the warriors could fire arrows faster than a single shot gun all while the horses were walking on their hind legs into the enemy. The horse's front legs were outfitted with obsidian knifes along with obsidian dentures. A horn resembling a unicorn was strap to their head. If the Spaniards could make it thru the slashing hoofs and snapping teeth then they got the 'horn'. Within a days' time the estimated population of nearly 8000 Spanish was reduced to less than 2500 -- the number that made it safety in El Paso. The displaced governor of the first settlement in the New World by the Spanish, Don Juan de Onate, made it to El Paso "only by the grace of God and a damn fast horse"- as it was reported to Mexico City . . . "The Indians attacked with shamelessness and daring." He did not exaggerate, and the Spanish government believed him. Spain's sweep through South America could be liken to a stroll through the streets of Madrid on a Sunday afternoon... challenging but pleasant and rewarding. Their conquest of western North America could be compared to a dash through a brier patch in the nude.... Not only was it embarrassing, but it also drew blood, specifically, Castilian blood.

When the Spanish took possession of Santa Fe; the Hopi moved all their worldly belongings

1690 to the inaccessible mesas of northern Arizona. By the Prospector Many of the fleeing In-

dians reached Eastern Oregon and Nez Perce, Arapahoe, Cherokee, established a home in the oldest Cheyenne, Blackfeet, Chinook,



mountains just south of Steens Mountain and gave the mountain range its name, Pueblos.

The Shoshoni - their appetite now whetted for blood - rode east to join forces with the Kansas horse rustlers (Comanche) and drove past El Paso to Monterrey Mexico where they found what turned out the greatest cultural game changer in North America's history, thousands of horses.

From the camps along the Red and Canadian Rivers the Shoshoni raided Spanish settlements for whatever they had to offer. War parties sometimes thrust hundreds of miles into Mexico and returned with as many as 1000 horses. The Spanish and Mexicans were regarded as feeble enemies. Most of the contraband was funneled back into the Shoshoni tribe called the Yuhtas, who the Spanish called the Utes. The Utes were the merchants of the Shoshoni Nation which sent the horses to their Brothers the Paiute, Zuni, Hopi, Flathead, and even their archenemy the Sioux Indians.

Pit River, Bannock, Mo-

doc etc. etc. The culls

were sold to their ene-

mies for a great profit...

Some of these cull horses were bred to become the most sought out by the 1800's. Named for the Nation that raised them, the Cayuse Horse out shined the Shoshoni horses. The very best horses, of course, went to the Ochocos. They found horse so plentiful in Mexico that the Comanche took up permanent residence to serve as a supply depot for the northern campaign. The Comanche were short legged, ungraceful people when on the ground but when mounted, were some of the showiest horsemen the world has ever known. Phineas Taylor Barnum called

them "greatest horsemen in the World". That was not a showmen boost. The Comanche's were also the world's greatest horse thieves.

Mystically certain of their superiority in the way of born riders, they regarded other people, white or red, as inferior beings. Prior to this raid into Mexico the only horses to be found in North America were under the Saydocarah Warriors who had been raiding the Spanish for over a hundred years. These warriors could ride from the Pacific Ocean to the Mississippi River and be worshipped as a God on these animals.

The Comanche's were now controlling from the Savanna River to western Texas and hooking down thru Mexico -- constantly changing their campsites. The Conquistadors called them the Ghost People.

Feeling confident their Brother the Comanche had the situation handled the Saydocarah, the Conquerors, rode home to the Ochocos, to their beloved land they called Oyer'ungun.

It is reasonable to believe that the name "Oregon" is derived from this Shoshoni word, for its similarity to Oyer'ungun cannot be denied. Then add the fact that both words, Oregon and Oyer'ungun translation are identical....

## A little About Special Transportation

Who can use the service, who can not. Well the simple answer is, Any one can use the services of the Special Transportation Program.

All you need to do is call **541-480-3221 Three days** in advance, further out is better but not required.

And be sure to leave a clear message so we can call you back. The coordinator will do her best to get you scheduled, but remember it will still depend on available space and driver availability.



Drivers for the Special Trans-

portation program are volunteers. They not only use their vehicle, they also are donating a good deal of their time.

#### **Transportation scheduling can be confusing**

Special Transportation is not the same program and Lake County Public Transit.

It is important to understand that Special Transportation drivers do not work for a wage. They are paid a stipend for their mileage and the cost of maintaining their vehicles. Frequently vehicles have more than one passenger and more than one appointment time to meet. At times this may make for a long day, especially if one appointment is at say 10am and someone else's is at 2pm.

So if you are confused about which service to use, check with the schedulers of both programs to see which services you qualify for. The real goal here is to get folks to medical care and also to get them to major shopping facilities.

Drivers may also have to take care of some of their own business, or shopping while a rider is at an appointment, or shopping somewhere else. Be patient, remember it is just as long a day for the driver as it is for you. If you know it will be an especially long day and you don't have funds to eat then please bring something to eat that will not make a mess in the car or stain upholstery.

We all love living out in the high desert and we all know that at times we will have to travel 60 to 100 miles to take care of health issues and major shopping. We encourage you to use the services and at the same time appreciate those that are making your rides and trips possible.
